

# Discount Eligibility

## Student Discounts & Class Pass

### Who qualifies for the student discount?

All eligible K-12 and full-time college students, defined below, are eligible. Student discounts do not apply to EZ transit passes. Visit one of our Transit Store locations to apply for your discounted student bus pass. Photo ID TAP cards are required with the use and purchase of any Foothill Transit discounted pass. A temporary TAP card will be issued to you along with a Foothill Transit student discount ID card (K-12 students do not receive a photo ID TAP card). A permanent discount TAP card will be mailed to the address you provide to us. Take a look below for details on the discounted pass and the requirements. **K-12 Students** Qualified applicants may submit applications for the K-12 student discounted pass at any time during the school year. The student's ID card will expire following the student's 8th or 12th grade graduation. K-12 students must be enrolled in an accredited elementary, junior high or high school in Foothill Transit's service area.

Applicants must provide one of the following documents listed below.

- Current report card (photocopy is accepted).
- Current valid school ID (photocopy is accepted).
- Computer printout showing enrollment units and/or in-class schedule (photocopy is accepted).
- Letter on school letterhead containing the original signature of a school official.

**College and Vocational Students** Qualified applicants may submit applications for a student discounted bus pass at any time during their current school term.

Undergraduate students must be enrolled in an accredited school in Foothill Transit's service area for a minimum of 12 units or 12 hours of in-classroom study per week for a minimum of three consecutive months. If you are enrolled in a summer/winter program that meets for less than 3 months or 12 units/hours, you can still qualify if you meet the requirements in the preceding spring/fall term. In this case, both summer and spring or winter and fall documents must be submitted with the application.

Graduate students must meet the minimum requirements of 3-4 units/hours per week to qualify.

Applicants must include one of the following documents listed below to prove eligibility along with a valid photo ID.

- Current registration/fee receipt, which includes the school term, the class schedule and units.
- Computer printout showing enrollment units and/or in-classroom hours. This document must be stamped by the registrar's office.
- Current contract or agreement between yourself and the school showing enrollment units and in-classroom hours.
- Current registration form or enrollment certificate showing enrollment units and/or in-classroom hours.
- Letter on school letterhead containing the original signature of a school official, verifying the start and end dates, and indicating the total number of units and/or days and hours of attendance.
- High school students entering college for the first time, must bring both the spring and summer or fall and winter enrollment documents with your application.

**Class Pass and More** Do you go to Mt. SAC, Citrus College, or University of La Verne? If you do, you may be eligible for a special semester long bus pass. It's called the Class Pass. The Class Pass allows credit students to ride Foothill Transit local lines and the Silver Streak to class, work or for fun. Foothill Transit is proud to partner with local colleges in the San Gabriel and Pomona valleys. **Pasadena City College** has partnered with the Metro and Foothill Transit to offer low-cost public transportation passes to PCC students. The Institution Pass Card (I-TAP) allows full-time students enrolled in at least 12 units to ride the Foothill Transit buses, Metro buses and rail lines for \$30 for the entire semester.

Students can obtain the I-TAP on campus. **Rio Hondo's** GO RIO program offers full-time students a transit pass good for use on Foothill Transit, Metro, Norwalk Transit, Montebello Bus Lines and the LA County Public Works Sunshine Shuttle.
